OJT is a type of training that is provided by an employer to a new employee or to advance an existing employee to a self sufficient wage.

The employer identifies their needs and trains the trainee with the skill-set to gain well trained, full time, and long term employees.

The training is required to provide the knowledge and skills necessary for the full and adequate performance of the job for which they have been hired.

Employers must commit to hire and retain the employee at the end of a successful training period.

During the training, the employee is engaged and trained for productive work for a job in which they are being paid.

ON-THE-JOB TRAINING REQUIREMENTS

- Each individual must be assessed and found eligible and suitable by the local OhioMeansJobs center before they are hired.
- The employer commits to hire and retain the individual if the individual completes a satisfactory training period.
- Employers must offer the same treatment and compensation that they offer to workers in the same or similar positions.
- Employers must not have laid off workers from the same or similar positions or use the On-the-Job Training to displace current workers or reduce their hours, wages or benefits.
